Brief Description of Institution

Al-Ayen University is a distinguished private academic institution established in October 2017. In a short period, the university has successfully established its academic presence by achieving significant scientific and administrative milestones. The university adopts an ambitious vision to become a leading global academic institution that shapes the future of higher education and scientific research to serve society through innovation and academic excellence. The university comprises 11 colleges, with 35 academic departments. As of 2026, the student body reached 33,000. The university operates across three main campuses with a specialised teaching hospital featuring 240 dental chairs and a teaching hospital with a capacity of 200 beds. The university's academic rigour is reflected in its inclusion in several global rankings and its active contribution to global scientific research, with the following documented statistics: 3401 papers indexed in Scopus. 2508 on the Web of Science.
